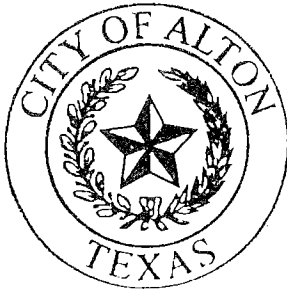
1. Adoption of Ordinance 2014-11, relating to amendments to the City of Alton Subdivision Ordinance, waiving third reading.
