1. Consider and approve Interlocal Agreement with Hidalgo County for roadway improvements.

Jeff Underwood, City Manager stated Interlocal agreement is for street improvements. The sections of roadway improvements are as follows: overlaying Inspiration road north of mile 6 for about 500 feet which inside city limits; mile 6 from Inspiration to Los Ebanos road and final section is mile 6 from Los Ebanos to Trospen. On this three sections are partially in the county so there is a split of the materials. The county provides labor and machinery. Material costs are split. \$41,759.21 is the city's portion. The other section is Trospen road, repaving from mile 5 through mile 6 which is a connecting roadway. The county will provide machinery and labor. The city will pay 100% of the material which is \$89,222.46 for a total cost of \$130,981 to get all roadways paved. Staff recommends approval.

Motion to approve was moved by Mayor Pro Tem Arturo Galvan Jr and second by Commissioner Ricardo Garza. Motion carried 4-0.



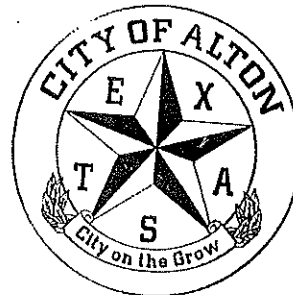
