PROJECT: City of Alton – Josefa Garcia Park Expansion Project

DESCRIPTION: This project consists of expanding the existing Josefa Garcia Park primitive trails, construction of soccer fields, parking lot, half basketball court, workout pavilion, and butterfly gardens. Electrical work will be required to provide lighting to the parking lot.

The bids will be publicly opened and read aloud as near as practical after 3:00 P.M. on January 28, 2022, at the Alton City Hall. Bids received after closing time will be returned unopened.

A bid bond in the amount of 5 percent of the bid issued by an acceptable surety shall be submitted with each bid. A certified check or bank draft payable to the City of Alton or negotiable U.S. Government Bonds (as par value) may be submitted in lieu of the Bid Bond.
